#### **CHANGE OF COMPANY NAME**

The Board is pleased to announce that the English name of the Company has been changed from “Wisdom Sports Group” to “China Frontier Technology Group”, and its new dual foreign name in Chinese has been changed from “智美體育集團” to “中國前沿科技集團”, both with immediate effect.

#### **CHANGE OF STOCK SHORT NAME**

The stock short name of the Company for trading in the Shares on the Stock Exchange will be changed from “WISDOM SPORTS” to “CH FRONTIER TEC” in English and from “智美體育” to “中國前沿科技集團” in Chinese, with effect from 9:00 a.m. on 31 July 2024. The stock code of the Company on the Stock Exchange will remain unchanged as “1661”.

References are made to the announcement of China Frontier Technology Group (formerly known as “Wisdom Sports Group”) (the “**Company**”) dated 30 April 2024, the circular of the Company dated 6 June 2024 (the “**Circular**”), and the announcement of the Company dated 28 June 2024 relating to the poll results of the annual general meeting held on 28 June 2024, in relation to the Change of Company Name. Unless otherwise defined herein, capitalised terms used in this announcement shall have the same meanings as those defined in the Circular.

#### **CHANGE OF COMPANY NAME**

The Board is pleased to announce that the English name of the Company has been changed from “Wisdom Sports Group” to “China Frontier Technology Group”, and its new dual foreign name in Chinese has been changed from “智美體育集團” to “中國前沿科技集團”, both with immediate effect.

Subsequent to the passing of a special resolution on 28 June 2024 to approve the Change of Company Name, the Certificate of Incorporation on Change of Name of the Company has been issued by the Registrar of Companies in the Cayman Islands on 3 July 2024, certifying the change of the English name of the Company and the new dual foreign name in Chinese of the Company to “China Frontier Technology Group” and “中國前沿科技集團”, respectively, with immediate effect. The Certificate of Registration of Alteration of Name of Registered Non-Hong Kong Company was issued by the Registrar of Companies in Hong Kong on 24 July 2024 confirming the registration of the new names of the Company in Hong Kong under Part 16 of the Companies Ordinance (Chapter 622 of the Laws of Hong Kong).

## **EFFECTS OF THE CHANGE OF COMPANY NAME**

The Change of Company Name will not affect any rights of the holders of securities of the Company or the Company’s daily business operation and its financial position. All existing share certificates in issue bearing the former name of the Company shall continue to be good evidence of title to such Shares and the share certificates will continue to be valid for trading, settlement, registration and delivery purposes. There will not be any arrangement for exchange of the share certificates of the Company under its former name for new share certificates under the new name of the Company. New share certificates of the Company will be issued under the new name of the Company with effect from 31 July 2024.

The stock short name of the Company for trading in the Shares on the Stock Exchange will be changed from “WISDOM SPORTS” to “CH FRONTIER TEC” in English and from “智美體育” to “中國前沿科技集團”, in Chinese, with effect from 9:00 a.m. on 31 July 2024.
